CANOEING RESERVATION APPLICATION

Thank you for choosing Northern Tier for your wilderness adventure. Please read the following information carefully before making your reservations.

NORTHERN TIER PARTICIPANT AGE REQUIREMENTS:

A participant on a wilderness canoe trek or a Lone Voyager program must be a registered Boy Scout, Varsity Scout, or Venturer. Youth participants must have attained the age of 13 by the end of the year that they attend. THESE ARE MINIMUM REQUIREMENTS!

Please remember that high adventure programs are designed for older youth members as an incentive to keep them in Scouting. Northern Tier programs are challenging and rigorous. Use good judgement in choosing your crew members.

ADULT LEADERSHIP:

The best available leadership should be recruited to accompany each crew. In keeping with the policy of the Boy Scouts of America there are no gender restrictions for adult leadership at Northern Tier, except that each coed crew must have coed adult advisors over the age of 21.

Each Northern Tier crew must have at least two registered adult leaders, or one adult and one parent, one of whom must be 21 years of age or older. Because Northern Tier's objective is to serve youth, every crew must have a majority of youth participants.

CREW SIZE: (Multiple Crews Welcome)

Atikokan: If going into the Crown Lands, maximum crew size is 12, including Interpreter. If going south into Quetico Park, maximum crew size is 9, including Interpreter. Both Fishing Expedition and Kayaking Treks are maximum of 9, including Interpreter even though they go north into the Crown Lands.

Bissett: Maximum crew size is 12, including Interpreter.

Ely: Maximum crew size is 9, including Interpreter.

COED EXPEDITIONS:

The Northern Tier invites chartered coed Venturing Crews to participate in High Adventure Expeditions. Each coed group is required to provide adult coed leadership (each must be at least 21 years of age) while en route to and from, as well as while participating in the Northern Tier programs.

RESERVATIONS:

1. **You must phone the base to receive a crew number and tentatively reserve a trip date.** You then have three weeks to send in your reservation form and the \$300 per crew reservation fee (deposit). If no reservation fee is received after three weeks, the reservation is subject to cancellation.
2. Please complete the enclosed reservation form. You will need to have a council signature along with a deposit of \$300 per crew (which is applied to your total fee) to secure your reservation. This deposit is not refundable if you cancel and is not transferable from one crew to another.
3. Reservations for the 2013 season begin at 8:00 AM Central Time on Monday, April 2, 2012.

WHAT DOES OUR FEE INCLUDE?

Regardless of which Northern Tier High Adventure trip you choose, we can outfit your expedition. Whether you are canoeing in the BWCAW/Quetico, exploring a beautiful Canadian lake or escaping to a remote wilderness fly-in adventure, we offer state-of-the-art equipment for tripping into the canoe country.

Our standard canoes are rugged aluminum, but we also provide the extra-cost option (at the Atikokan and Ely bases) of lightweight kevlar and fiberglass canoes. We have spacious Granite Gear personal gear packs and Kondos equipment packs. Our tents are freestanding Outfitter models with mosquito netting and rain flies. We provide nylon trail tarps for rain protection, Coast Guard approved life jackets, paddles, cooking utensils, nesting pots, trail ovens for baking and ropes to hang food packs. Each crew will also be outfitted with an emergency communications system. Northern Tier is the ONLY outfitter in the BWCAW to issue emergency radios or satellite phones as part of our standard gear.

All Northern Tier bases offer outstanding trail food. We combine military style food packets of meats and fresh goods to create trail meals that taste as good as home-cooking. Every crew has the benefit of up-to-date information on menus, equipment and techniques developed from over 85 years of outfitting experience. At Northern Tier we believe that quality gear and good food are the cornerstones to a great trip. We also believe in education and provide qualified instruction in canoeing, cooking, low impact camping, fishing, and wilderness safety skills.

A trained and experienced staff member, called an Interpreter, will act as a resource to the crew. These Interpreters are trained in nature, route finding, area history, canoeing, cooking, and many other wilderness skills. Their role is to act as a resource and to ensure that the crew has a safe and fulfilling adventure. Each group will have an Interpreter join the crew upon arrival to accompany you through the remainder of the trip. For our billing, he or she is not considered to be a crew member.

CREW PAYMENT SCHEDULE AND POLICY

1. \$300.00 Deposit per crew – Due within 3 weeks of reservation. **Non-refundable/Non-Transferable - Subject to cancellation if late.**
2. \$1,000.00 per crew – Due Oct. 1 or within 3 weeks of reservation. **Non-refundable/Non-Transferable - Subject to cancellation if late.**
3. Balance of Payment – June crews – March 1st; July crews – April 1st; August crews – May 1st; confirm the number of youth and adult participants on your Final Billing Statement. **After your Final Due Date your participant camping fees are non-refundable. Please confirm attendance PRIOR to submitting your final payment.**
4. Crew refunds due outside of these policies (i.e. camperships) will be confirmed upon arrival. All refund requests must be submitted in writing. Crew refunds are processed through the National Office in Irving, TX.
5. All refund requests must be submitted within 30 days of crew arrival date.

ALL FEES (Deposit, Additional Crew Payment and Balance of Payment as indicated in fee payment schedule) ARE NON-REFUNDABLE AND NON-TRANSFERABLE TO THE BALANCE OF FEES IN EVENT OF CANCELLATION. BE CAUTIOUS OF MAKING RESERVATIONS OR PAYING FEES FOR THOSE WHO HAVE NOT MADE A FINANCIAL COMMITMENT.

Northern Tier High Adventure Program must commit financial resources to employ staff, purchase food and supplies, and prepare for base operations. Participants are, therefore, also required to make a financial commitment to attend. Be conservative in making reservations to avoid losing fees due to cancellations.
